Community includes family groups, charities (endorsed by Australian Taxation Office and registered as an approved charity for tax concession purposes) and (where SOPA, in its sole discretion, considers appropriate) a DGR.

Concession is a discounted fee or charge for identified persons or groups e.g. pensioners or students

DGR means a deductible gift recipient within the meaning of the Income Tax Assessment Act 1997 (Cth)

Licence means the agreement granted by SOPA to the Licensee to conduct an approved activity within Sydney Olympic Park.

SOPA means Sydney Olympic Park Authority constituted under the *Sydney Olympic Park Authority Act, 2001 No 57*.
